3. The Candidates must fulfils the eligibility for contesting the election as provided in the Multi State Co-Operative Societies Act 2002 and Rules 2002.
4. The candidates have to deposit Rs. 2000/- by Cash only with the Returning officer, while filing the nomination
5. The Election Programme is published in the Office of the Returning officer's office and Head Office of the Society and at the branches of the Society and on the official website of the society <https://www.galaxynmultistate.com>
6. The list of specified symbols available for the election will be displayed on the notice board of the Returning Officer.
